The meeting was called to order at 5:02PM by Joe Gimenez. A quorum was established with all five Board Members present.

- 1. Review and consider and take action to approve minutes of prior meetings.
 - 1. Tabled approving March 9, 2019 Annual Member meeting minutes as they are not yet ready for review
 - 2. Motion made and carried to approve March 14, 2019 meeting minutes
- 2. WATER PUMPING BARGE Update to possibly include authorization for expenses, insurance handling, etc. Review, discuss and take any appropriate action.
 - 1. Good News from George. All four pumps are in place and working. The barge is also in place. WIP to resolve a few minor hardware details.
- 3. REAUTHORIZE APPLICATION FOR LINE OF CREDIT WITH FIRST UNITED BANK Review, discuss and take any appropriate action.
 - 1. Joe and Bill recently learned our WOWSC revolving line of credit expired last year.
 - 2. \$125,000 line of credit is available at First United Bank
 - 3. George does not recall WOWSC previously using a line of credit.
 - 4. Bill to gather additional information on the line of credit.
- 4. Briefing on recent and pending records requests under the Texas Public Information Act and take appropriate action to assign and clarify responsibility of Public Information Officer and other WOWSC representatives.
 - 1. WOWSC has recently received five PIA requests
 - 2. Mike Gershon recommends WOWSC Board appointing a Public Information Officer
 - 1. Mike Gershon recommends George Burris fulfill PIA requests and that the WOWSC Secretary be the Public Information Officer
 - 2. Lloyd Gosselink is available to help with PIA responses. Hannah is a legal assistant working for Mike Gershon who has been helping with WOWSC's recent PIA responses.
 - 3. Joe Gimenez proposed forwarding all future PIAs to WOWSC Public Information Officer and Hannah for responses.
 - 4. Joe Gimenez proposed Dorothy Taylor, as a volunteer, be the WOWSC Public Information Officer. Mike Gershon to investigate this proposal.
 - 3. Motion made and carried for Joe Gimenez to be the temporary WOWSC Public Information Officer
- 5. Briefing on Texas Open Meetings Act training and certification due within 90 days of taking the oath of office.
 - 1. Mike Gershon to check on duration of Texas Open Meetings Act training certification.
 - 2. Provide certificates to George for records filing
 - 3. Joe noted no oath of office was administered at March 9 meeting to initiate 90-day timeline for training and certification. Gershon to provide counsel.
