- b) ZEBRA MUSSEL PROJECT Update on efforts to secure regulatory agencies approvals for installing strainer on the pump manifold on raw water intake barge to remove particles larger than 35 microns with automatic backwash capability.
 - i) George is working to obtain approvals for the strainers. George has contacted TCEQ, LCRA, and TPW. George received initial feedback and is planning to submit an updated request.
- c) REGULATORY COMPLIANCE REPORTS Update on results from recent inspections, including but not limited to the 2020 Consumer Confidence Report and Comprehensive Compliance Investigation by the TCEQ.
 - i) TCEQ's virtual compliance investigation of the WTP had a perfect report. It is to be posted on WOWSC's website and included in a communication to members.
- d) CLARIFIER Update on progress of engineering plans, pricing comparisons, and possible installation for clarifier and storage tank related to system growth.
